#### **MiPMC**



- Michigan Association of Municipal Clerks (MAMC)
- Obtained by completing 3 years of Michigan Municipal Clerks Institute OR obtained MMC through IIMC
- Advanced "levels" (2,3,etc.) can be achieved after initial MiPMC certification


#### **CMC**



- International Institute of Municipal Clerks (IIMC)
- CMC (Certified Municipal Clerk)Obtained by completing the CMC program through the IIMC
- MMC (Master Municipal Clerk) can be achieved after initial CMC certification. Education Plus Program \*new\* (EPP) after MMC.



#### MiPMC CERTIFCATION – 3 STEPS

- Be an active member of MAMC, attend 3 years of institute.
- Graduate institute.


#### MIPMC ADVANCED CERTIFICATION



- From the date of your MiPMC Certification, start collecting points for advanced certification.
- MAMC member in good standing and:
- LEVEL 2 accumulate 20 POINTS
- LEVEL 3 accumulate 50 POINTS
- The point structure is outlined in the MAMC guidelines and on the ADVANCED CERTIFCATION APPLICATION

Requirements for MiPMC Advanced Certification Applicants	
MAMC Summer Conference (Wed-Thur-Fri)	6 (2 points per day)
MAMC Master Academy (3-days)	6 (2 points per day)
Free Education Day	2
2-Day Clerking 101 Bootcamp @ Summer Conference (Mon &Tues)	4 (2 points per day)
Preconference Masters @ Summer Conference (Tues)	2
Miscellaneous Coursework*	6 for Level Two 20 for Levels Three and Higher Note: any or all of the points allowed under this category can be either in-person or on-line training
Teaching class/speaking at MAMC or other Association events associated with the Clerk profession	1 point per class taught or per speaking event
Serving as an Officer of an Association relative to the Clerk profession	1 point per year served as an Officer of an Association relative to the Clerk profession

Points earned prior to attaining original MiPMC certification shall not be applied toward additional levels. Applicants may apply for one level at a time.

The point structure is equal to two (2) points for each 6 hours of class, or one (1) day.

- Other coursework should be submitted to the MiPMC director for approval.






- Create a "Me File". Keep it organized to keep track of classes, points and certificates earned.
