- I got a text that said I didn't vote yet, but I early voted yesterday. Why didn't my vote count?
- (On Monday) Why can't I early vote today?
- (On Election Day) Do you have early voting today?

And that's just the tip of the iceberg! But no matter how many questions we answer or challenges we face, we always push through, for Clerks are resilient and tenacious!

Now that the Presidential Election is behind us, there's still plenty of work ahead — cleanup, recounts, audits, and catching up on everything else that got sidelined. But we made it through. And we did it, relatively unscathed.

Christina M. Rush, MiPMC

City Clerk of the Year

City of Montrose

Christina "Tina" Rush began her career as City Clerk for the City of Montrose in October 2002. Prior, she worked as a Clerk/Receptionist in Montrose Township, Deputy Clerk in Vienna Township, and Secretary in the Village of Chesaning between 1999 and 2002.

As Clerk, Tina created personnel policies and job descriptions that were outdated since 1997. In 2005, she executed the first codification since the city became incorporated in August 1980. She even served temporarily as Interim City Manager. In December 2015, Tina received the Loretta Manwaring Award from the Genesee County Governmental Clerk's Association, and in July 2017, she was awarded Citizen of the Month in the City of Montrose.

Tina has been a member of MAMC since 2003 and IIMC since 2004. She is also a trustee of the Genesee County Governmental Clerk's Association and has been president of the Genesee County Clerk/Treasurer Association since February 2017.



Jody Hansen, MiPMC **Township Clerk of the Year**Allendale Charter Township

While new to the role of Township Clerk, elected in 2020, Jody is no stranger to the profession, having worked at the Ottawa County Clerk's Office for eight years, performing such duties as pre-election testing, assisting with Election Inspector Certification classes, post-election audits, election recounts, and presenting several times at the Ottawa County Clerk's Association (OCCA) meetings.

In her first year as Clerk, Jody was elected secretary of the executive board of the Ottawa County Clerk's Association. She served as President of the county association and is a board member of the West Michigan Regional Clerk's Association. As president she helped develop subcommittees to spearhead legislative changes surrounding the impacts of Proposal 2022-2 and early voting. Additionally, she developed a relationship with Grand Valley State University to implement a Satellite Clerk's Office on campus.

Village Clerk of the Year

Village of Parma

Joanne Havican was appointed Clerk of the Village of Parma in 2017 and elected the following year. Joanne has joined multiple organizations such as the Michigan Municipal League, MAMC, Region 2 Planning commission Executive Committee, Kalamazoo River Watershed Council, Parma Local Development Finance Authority and the Parma Sandstone Fire Board. She is a member of the Jackson County Municipal Clerks Association.

Joanne has focused on the benefits of additional funding and has taken on training for grant writing to support her community.

In her role, interpersonal relationships that needed to be mended between two Townships and the village, as well as between the boards, have been slowly repaired after Joanne was able to open dialogue between the separate groups.



Lynn M. Henry, MiPMC2/CMC Township Clerk of the Year Grand Blanc Township

Lynn, Deputy Clerk of Grand Blanc Township, began her municipal career as the part-time Assistant to the Clerk in the City of Linden in July 2012. By September of that same year, Lynn became the City Clerk. In 2018, she became the Deputy Clerk at Grand Blanc Township, her current position. Her commitment to education and training as a professional clerk throughout her career is highlighted in her achievement of the MiPMC2 designation from MAMC and CMC designation through the International Institute of Municipal Clerks.

In 2022, Lynn became a Board Member of MAMC and quickly advanced to her current assignment as Education Chair. MAMC Past President Jacqueline Beaudry, in her nomination, highlighted Lynn's "110% commitment" to the MAMC Board from day one, stating it was Lynn's leadership and hard work that facilitated the creation of the 2023 U.P. Education Day.

Bylaws Amendment Approved and Dues Increase

On June 19, 2024 the general membership approved changes to the bylaws at the Annual Conference Membership Meeting at Grand Traverse Resort.

The bylaws initially required that the membership approve any increase in dues with 30 days' notice. This had resulted in missed opportunities to address the expanded needs of the organization and meet the demands of inflationary economic pressures on the organization. As a result, Article III – Membership, Section 5, Dues was amended to allow the Board of Directors to alter the dues structure subject to a membership referendum. The updated bylaws are available on the MAMC website.

Additionally, the membership voted for the 2025 dues to be set as follows: \$100 annually for members and \$125 annually for associate members. The announcement of this proposed increase was also presented at the April 9, 2024 Member Education Day in Mt. Pleasant.

Education Report

Lynn Henry, MiPMC3/CMC Chair, Education Committee

We hope everyone who attended the 2024 Annual Conference enjoyed the education sessions. Our team strives to provide relevant topics at each event.

After every event we are always asked about education points and certifications. Information regarding certification can be found on the MAMC website at: https://michiganclerks.org/certification/ and on the IIMC website at: https://www.iimc.com/121/Certification

The following is a brief review of the different associations, certifications, and education point system.

For MiPMC certifications, education points are earned at 2 points per 6 educational hours, or per day.

For CMC and MMC certifications, education points are 2. Must complete an Application for Admission earned at 1 point per 2 educational hours for an IIMC approved Institute and at 1 point per 4 educational hours for a State (MAMC) education program and require the completion and submission of a learning assessment.

Michigan Association of Municipal Clerks (MAMC) International Institute of Municipal Clerks (IIMC)

CERTIFICATIONS:

Michigan Professional Municipal Clerk (MiPMC)

This certification is attained through MAMC. The requirements for the MiPMC certification are:

- 1.Must be an active member of MAMC
- 2. Must have accomplished one of the following:
- a. Completed Michigan Municipal Clerk's Basic Institute
- b. Attained IIMC MMC Certification

Rachelle Enbody, MiPMC2/CMC Vice-Chair. Education Committee

Each subsequent level of MiPMC Certification requires having accumulated an established number of education points (20 points for Level 2 certification and 50 points for each level of certification thereafter).

Certified Municipal Clerk (CMC)

This certification is attained through IIMC. The requirements for CMC certification are:

- 1. Must be an active member of IIMC for two years.
- 2. Must complete an Application for Admission
- 3. Must complete and Application for Designation
- 4. Requires having accumulated sixty (60) education points AND fifty (50) experience points.

Master Municipal Clerk (MMC)

This certification is attained through IIMC. The requirements for MMC certification are:

- 1. Must be an active member of IIMC for two years.
- 3. Must complete an Application for Designation
- 4. Requires having accumulated sixty (60) advanced education points AND forty (40) professional points.

Lame Duck on the Move

With the November elections in the rear-view mirror, Legislators returned to Lansing to wrap up the session while Democrats still hold the trifecta. Numerous election-related legislation remains on the priority agenda for December.

Senate Bills 401-404: Creating a Michigan Voting Rights Act. The bills passed the Senate and are in the House Elections Committee awaiting action.

Senate 1068: Makes numerous changes modernizing, clarifying and updating various sections that spell out the rights and responsibilities of challengers. The bill was reported from the Senate Elections Committee and is awaiting action by the full Senate.

House Bills 6052-6055: Provides for numerous clean-ups to the original Proposal 2 implementation legislation enacted last year. This is not unusual to introduce clean-up legislation after a major piece of legislation has been implemented. These bills are awaiting full action by the House.

<u>House Bills 5699-5702</u>: Establishes the Oath of Office for local offices cannot commence sooner than the first day of the month following the election. These bills passed the House and are awaiting for action in Senate Elections Committee.

The session concludes no later than December 31, 2024. All bills failing to pass and not sent to the Governor die at the conclusion of the session and must be reintroduced next session.

Republicans Take Control of Michigan House

Voters ousted four Democrats, giving Republicans control of the Michigan House of Representatives for the 103rd Michigan Legislature. Democrats currently hold a slim 56-54 majority. When Republicans take the gavel on January 8, 2025, they will have a little more breathing room with a 58-52 seat majority. The four Democrat incumbents losing re-election were Rep. Nate Shannon (D-Macomb County), Rep. Jenn Hill (D-Marquette County); Rep. Jaime Churches (D-Wayne County); and, Rep. Jim Haadsma (D-Calhoun County), who lost re-election by a mere 58 votes. While the State Senate was not up for election, it is noteworthy to mention that with Democrat Sen. Kristen MacDonald Rivet winning the 8th Congressional District, the state Senate Democrat majority will slip to 19-18 in that chamber 1until a special election is called to fill her vacancy.

With Republicans seizing control of the State House, Minority Leader Matt Hall (R-Kalamazoo County) was selected by the Republican caucus to be Speaker of House for the 103rd Session of the Michigan Legislature. Current Speaker Joe Tate (D-Wayne County) stepped down after the election losses opening the door for Rep. Ranjeev Puri (D-Wayne County) to take control of the minority caucus.

Looking to the House Election Committee next session, there are three former Republican clerks serving who could be poised to chair the committee or serve on the committee. Two former clerks, Jay DeBoyer (R-St. Clair), a former county clerk, and Rachelle Smit (R-Allegan), a former township clerk, currently serve on the committee and could seek reappointment to the committee or appointment as chair.

Rep. Ann Bollin (R-Livingston), a former township clerk, served as chair of the committee during the 101st Michigan Legislature and moved to the House Appropriations Committee this session winding down. All three could end up serving on the committee, which has seen substantial activity this session.


